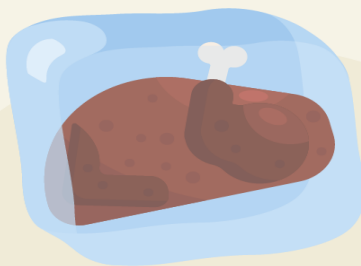

* **SUSPICIOUS PERSON** – Seberger Rd., Upon arrival, caller advised an unknown male parked in her driveway and walked up to one of her windows and took a picture. The subject was a white male with dark clothes driving a white SUV and it took place on 11/11/23 at approximately 1307 hours. The complainant advised the subject appeared to have looked inside her office window and took a picture. Unknown who or why they took the picture. Caller wished this incident documented.

* **BURGLARY** – Burr Ridge Circle South – The R/P advised that between 4:00pm (11/14/2023) and 7:00am (11/15/2023) an unknown party/s entered the home (under construction) and removed 2 doors and 10 windows without the permission of the property owner. The R/P was made aware of the theft when the employee tasked with installing the windows and doors advised him of the missing items.

* **ORDINANCE VIOLATION** – Genoa Ct. – I was dispatched to the location in reference to multiple vehicles with expired plates. Upon arriving code enforcement I met with code enforcement Who was already there. Two vehicles were located with expired plates and I spoke with the owner of the vehicles who advised she would move them off the street.



ATTEMPTED THEFT FROM VEHICLE – Wren Dr., Schererville officers were dispatched to Wren Dr., in reference to theft from two vehicles at the residence. The complainant stated it occurred between sometime early evening on 11/17/2023 to early morning on 11/18/2023. Additionally the complainant said both vehicles were left unlocked, but nothing was missing from them. The complainant just requested this be documented due to the vehicles being ransacked.

ATTEMPTED THEFT FROM VEHICLE - Crane Ct., I spoke to the complainant whom stated that two (2) of her vehicles which were parked in her driveway, were ransacked. The subject stated that it occurred sometime between 12:30 AM and 07:58 AM, on the date of this report. Additionally, the subject stated that the vehicles were left unlocked, but nothing was missing from them.



- * **ATTEMPTED THEFT FROM VEHICLE** – Dove Dr., Schererville officers were dispatched to the address above in reference to theft from three vehicles at the residence. The complainant stated it occurred between sometime between 11:56 PM through 7: 30 AM this morning. Additionally the complainant said all vehicles were left unlocked but one vehicle was missing some cash.
- * **THEFT FROM VEHICLE** – Dove Dr., I was dispatched to Dove Drive in reference to theft from a motor vehicle. I spoke with the R/P whom stated her 2018 GMC Terrain was left unlocked on November 17, 2023 and when she woke up this morning around 7:45 AM to head to work she observed her car to be ransacked. The R/P said she was missing her black Coach wallet with an estimated value of the wallet to be \$300. The R/P was missing \$80 cash that was left in her wallet, her social security card, drivers license, a debit card from Centier Bank and 2 credit cards from Chase Bank and Discover. The R/P was also missing an abundance of giftcards that she had left in her wallet, unknown value at this time.
- * **CRIMINAL MISCHIEF** – Wild Bird Ct., Officers were dispatched to Wild Bird Cr.in reference to a suspicious incident, someone threw eggs at the complainants house. On scene I spoke with the complainant who showed me where 2 eggs had been thrown at his outside kitchen window. Complainant was unsure if there was damage to the window due to it being high up but wanted a report made just in case there was damage.

**Sec. 6-190 Fires Prohibited in Railroad Rights-of-Way.**

a. From and after the legal passage, adoption and publication of this ordinance, it shall be unlawful for any person, firm or corporation to cause to be ignited or initiated any fire whatsoever upon any railroad right-of-way within the Town of Schererville, Lake County, Indiana, for which adequate measures have not been taken prior to igniting or starting said fire to insure that said fire will not spread through or to adjacent or contiguous real property or improvements thereto or foliage growing or situated thereon or cause any damage to personal property of any nature whatsoever located on adjacent or contiguous real property.

b. For the purposes of this ordinance, the term "adequate measures" shall be defined as and only deemed to include the appropriate and necessary placement and situation of necessary personnel and firefighting equipment by the person, firm or corporation starting or igniting such fire to prevent the spread of the same.

c. From and after the legal passage, adoption and publication of this ordinance, it shall be unlawful for any person, firm or corporation to permit or allow any fire whatsoever ignited or started upon any railroad right-of-way within the Town of Schererville, Lake County, Indiana to spread or extend to any adjacent or contiguous real property or improvements thereto or foliage growing or situated thereon or to any personal property of any nature whatsoever located on said adjacent or contiguous real property.
