Are you familiar with the 9 p.m. routine? The 9 p.m. routine encourages residents to conduct security checks at their homes and vehicles each evening to ensure their property is secure.

Everyone is encouraged to set a reminder and at 9 P.M. each evening, ensure the following tasks have been completed:

- Vehicles, residences, garages, windows, gates, sheds have been locked
 - Exterior lights, security cameras, alarm systems have been activated
- Valuables from vehicles (including keys), yards, patios have been brought inside

By participating in the 9 P.M. Routine, residents can help reduce the opportunity for residential burglaries and thefts.

- Theft 2/19 Fountain PI Complainant stated packages were taken from her doorstep. The suspect is possible a delivery person. She provided video of the incident. Investigation ongoing.

Complainant stated AT&T told her they do not use third party contractors. Extra patrol was requested for the next day.
- Ordinance Violation 2/21 Golfview Dr Complaint of an increase of vehicles with out of state plates staying in the area. Complainant requested extra patrol. Officers will be checking for registration violations.
- Suspicious vehicle 2/22 Sienna St Report of a suspicious and unknown vehicle parked outside of a residence. Officers responded and located the vehicle. Investigation led to 1 subject being arrested on multiple drug charges.
- Suspicious Person 2/24 Manchester Ln Report of a male subject that was observed walking near the house. He was wearing an orange jacket or shirt and was covering his face each time he was seen. Officers checked the area but were unable to locate the subject.
