- * THEFT Redar Park Ofc T Mele met with the R/P at the police station who stated she was at Redar Park on 9/20/2023 and had placed her cell phone inside a bag pocket and left the bag on bench. The R/P stated she was getting ready to leave, she noticed the cell phone missing.
- * FRAUD Timberwood Ln., The R/P stated that earlier in the day while on her computer inside her residence, a message popped up advising her that her computer had locked up and that she needed to pay to get it working again. These messages later turned into text messages after giving the subject on the other end her cell phone number. She first received text messages instructing her to withdraw \$15,000 from her back accounts and send them to this unknown subject via Bitcoin.
- * FRAUD Persimmon Dr. I spoke with the R/P who stated that she wanted to report that she made an \$11,000 investment with an online investment company, Rolly Investment Group. The R/P stated her money was transferred through Coin Base Inc., 885 Teaneck NJ 07666, Cross River Bank. The R/P stated not long after she realized her money was transferred to Bitcoins



without her permission and was not longer in her investment account. The R/P stated she contacted Rolly Investment Group and they contacted her back with Whatsapp and spoke with a male and female who identified themselves as Gabriel Wieseman and Melisa Coreck. She stated they both spoke in English and Polish and told her she lost the money in investments and after that his number was no longer a working number.

* THEFT – Fountain PI. - I responded for a cold package theft. Upon arrival, I spoke to the complainant about the incident. She explained that she was asleep around 2:15pm when her package from Temu was stolen off her porch. The woman's clothing valued at approximately \$50.00 was on the porch when a white male in a black Chevrolet pickup truck pulled up in front of the residence. The theft was captured on her Vivint security doorbell. The newer model, possibly a Z71 Trailboss, appeared to have factory tinted windows and black r rims. The white male was possibly in his forties to fifties with a white chin beard or goatee. He was wearing a black, backwards Under Armour hat, sunglasses, black hooded sweatshirt with white cursive writing, blue jeans, and black shoes. The male exits the driver's side front door leaving it open as he walks to the front door of the residence. A white, dark-haired, female can be seen wearing a green top in the passenger seat of the vehicle.





* THEFT – Govert Dr - Complainant reported the theft of a package. She stated she received a notification and picture from FedEx that a package was delivered and left in her mailbox at approximately 11:43 a.m. When she went to get the mail later in the afternoon she discovered the package was missing. The box contained medicinal supplies for her son. She stated at first her ring doorbell captured a red vehicle near her mailbox but on review the red vehicle passed by several minutes before the FedEx truck arrived.

Ordinance of the week

Ordinance of the Week:

Sec. 6-139 Specific Nuisances Highlighted.

a. The Town of Schererville has determined that the following list shall be considered examples of nuisances that shall receive written notice prior to issuance of a citation:

Trash, abandoned vehicles, overgrown vegetation, inoperable vehicles, garbage, refuse, untethered animals whether livestock or pets, sewage, obnoxious odors, conditions that attract infestation of rodents, insects, domestic or wild animals to create a health hazard or unsightly conditions, which act as detriment or danger to or interferes with, or unreasonably hurts or hinders the citizens of this community that have a right to the use and enjoyment of their property, or encroach injuriously on the enjoyment of others' lives or property, or to the aesthetic well being of the Town.

b. The Town of Schererville has determined that the following list shall be considered examples of nuisances that shall be immediately corrected:

No person within a residential or commercial zoning district shall make or cause to be made any sounds or vibrations perceptible without the aid of instruments beyond the property boundary of the sound or vibration source that interferes with, or unreasonably hurts or hinders the residents of this Town who have a right to the use and enjoyment of their property, or encroaches injuriously on the enjoyment of others' lives or property.

c. The list of nuisances set forth in subsections a. and b. are not to be considered limitations of any other condition which may qualify as a nuisance pursuant to the definition set forth in Section 6-138.
