Ordinance of the week

Sec. 7-72 Minimum Size of Numbers.

The assigned street number display shall employ arabic numerals of a minimum of three inches (3") in height, the color of which must clearly contrast with the background upon which they are placed.

October is National Bullying Prevention Month in the United States. Parents,

teachers, and students are all encouraged to help raise awareness about bullying throughout October in the following ways:
