**WHAT CAN YOU DO?**

You should not approach just anyone. If you need help, look for a uniformed police officer or a store clerk with a nametag.

### DON'T SAY:

Stay away from people you don't know.

### DO SAY:

It's important for you to get my permission before going anywhere with anyone.

### DON'T SAY:

You can tell someone is bad just by looking at them.

### DO SAY:

Pay attention to what people do. Tell me right away if anyone asks you to keep a secret, makes you feel uncomfortable, or tries to get you to go somewhere with them.

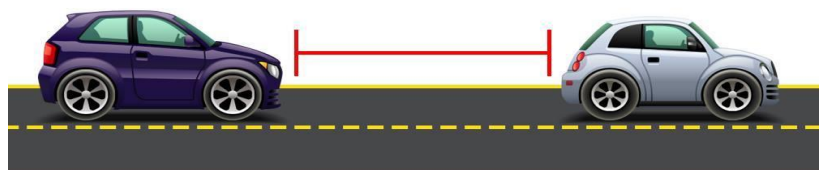

Caller continued to provide information and direction of travel. Upon arrival, officers attempted to locate the mentioned vehicle. After checking the area for several minutes, officers were unable to locate the vehicle.



This space should be **2-4 SECONDS LONG.**

**Sec. 6-49 Open Burning Prohibited, Nuisance.**

- a. No person or persons shall open burn any material except as provided at 326 IAC 4-1-1, *et seq.*
- b. Any person who shall violate any provision of this section shall be deemed a person maintaining a public nuisance.
- c. The Metropolitan Police Department shall and is hereby empowered to enforce the provisions of this section, as amended from time to time.
