PUBLIC SAFETY AWARENESS MARIJUANA Candy



Marijuana candy and other edible forms pose a great risk to users, especially children, who may receive it. Marijuana candy is illegal in Alabama as it contains Tetrahydrocannabinol (THC) which is the main active ingredient that causes a high. THC in candy can be as high as 90% compared to 10% to 20% found in marijuana vegetation.

Edibles may take longer to have effects so children and teens might think they need to take more to get high and end up overdosing.

* If you feel you or your child may have received candy or edibles, contact the Schererville Police Department immediately.

* Wear gloves when handling and wash hands immediately after to prevent potential ingestion of any drug particles.

HOW TO IDENTIFY

EXAMINE PACKAGING

Check for unusual packaging. Some packaging might look similar to the brand name candy however the name may be different.



Sometimes the name might appear the same so other identifiers may be marijuana leaves on the packaging or the warning symbol



SMELL

Because the packaging may look similar, marijuana candy can have an odor similar to that of the marijuana plant making it easier to identify.



SAFETY FIRST

Personal Safety Tips & Maintaining Situational Awareness

- Always be aware when you are pulling in or out of your driveway. Look around the area of your garage before pulling in and look at your rear view mirrors to check for any suspicious individuals before closing your garage and exiting your vehicle. Beware of individuals who may be hiding behind your vehicle or garbage cans.
- Always try to park in well-lit areas when possible that are visible to the public, and make it a habit to start your car and drive away immediately when possible.
 - If you believe that you are being followed, call 911 and try to get to a public area.
- Do not stop for stranded motorists who you do not know. Call 911 to get help on the way for them.
- If someone bumps the back of your vehicle while driving, continue to proceed to a safe area in view of the public if your vehicle is drivable and call 911 on the way there to get the police enroute.
- Try to bike, walk, job, or shop with a family member or friend when you can as criminals are more likely to approach someone who is alone. Look out for each other while in parking lots. If you do not feel safe walking out to your car, call 911 to request an escort by an officer.
- Avoid walking alone at night or sitting inside of vehicles in dark areas.



Ordinance of the Week:

Sec. 6-138 Nuisances Declared.

A nuisance is determined to be whatever is injurious to health, comfort, safety or indecent, or offensive to the senses, or an obstruction to the free use of property, so as essentially to interfere with the comfortable enjoyment of life or property or the aesthetic well being of the community.

Sec. 6-139 Specific Nuisances Highlighted.

a. The Town of Schererville has determined that the following list shall be considered examples of nuisances that shall receive written notice prior to issuance of a citation:

Trash, abandoned vehicles, overgrown vegetation, inoperable vehicles, garbage, refuse, untethered animals whether livestock or pets, sewage, obnoxious odors, conditions that attract infestation of rodents, insects, domestic or wild animals to create a health hazard or unsightly conditions, which act as detriment or danger to or interferes with, or unreasonably hurts or hinders the citizens of this community that have a right to the use and enjoyment of their property, or encroach injuriously on the enjoyment of others' lives or property, or to the aesthetic well being of the Town.

b. The Town of Schererville has determined that the following list shall be considered examples of nuisances that shall be immediately corrected:

No person within a residential or commercial zoning district shall make or cause to be made any sounds or vibrations perceptible without the aid of instruments beyond the property boundary of the sound or vibration source that interferes with, or unreasonably hurts or hinders the residents of this Town who have a right to the use and enjoyment of their property, or encroaches injuriously on the enjoyment of others' lives or property.

c. The list of nuisances set forth in subsections a. and b. are not to be considered limitations of any other condition which may qualify as a nuisance pursuant to the definition set forth in Section 6-138.

Sec. 6-140 Designation of Nuisances.

The Town Council, the Police Department, the Code Enforcement Officer, the Town Manager and/or his assistant or designees may determine what condition can be considered a nuisance.
