


DISCARD UN-USED MEDICATION SAFELY!

Ordinance of the Week:

Sec. 8-29 Park Areas - "Slow Children Playing".

Signs reading "Slow Children Playing" or signs with words of similar import shall be placed on all streets in the area of a park within the Town of Schererville, Indiana.
