* **RECKLESS DRIVER** – Phillips Rd & Coffman Dr. - I was dispatched to the area of Phillips Rd and Coffman Dr in reference to a silver or brown colored Acura sedan occupied with approximately five (5) females who were throwing items at the RP's vehicle. RP made a report with Griffith Police Department where the incident occurred but wanted the area of Prairie Estates sub division checked as the vehicle was last seen entering. The area was checked without success.

* **RECKLESS DRIVER** – St. Andrews Dr., Complainant advised a car drove close to her causing her to fall off her bicycle. Upon arriving I spoke with the complainant who stated that at approximately 4:15 PM, while driving her bicycle east on Inverness Lane with her husband, she stopped at the stop sign. She stated as she began to proceed forward a black Honda SUV driven by a white male approximately 25 years old with brown hair disregarded the stop sign as he turned left onto Inverness Lane from St Andrews Dr.

* **PROPERT DAMAGE** – Greenfield St., I responded to a call where the complainant's fence was damaged. Upon arrival, I spoke with the complainant who advised that someone kicked in her fence at approximately 11:30pm on August 1, 2023. She supplied security camera footage of the incident.

* **PROPERTY DAMAGE** – Taylor St., At approximately 9:30pm Last night (08/03/2023) three teens damaged his fence. The R/P showed me the fence which had one fence panel knocked off and one fence panel missing. The R/P was also able to show me video footage from his security cameras, which showed three juvenile males walk past the house but did not show them causing the damage.

Ordinance of the Week:

Sec. 6-178 Discharge of Firearms Prohibited.

After the legal passage, adoption, and publication of this ordinance, it shall be unlawful for any person, firm, or corporation to discharge or fire, or to suffer, permit, or allow to be discharged or fired, any pistol, gun, rifle, shotgun, air rifle, BB gun, or any other firearm whatsoever, including bows and arrows, within the municipal limits of the Town of Schererville, Lake County, Indiana, except as hereinafter provided.
