Chief Pete Sormaz and the Schererville Board of Safety are pleased to announce that applications are being accepted for the next session of the Schererville Citizens Police Academy.

Schererville residents and business owners 18 and older are eligible to apply for the 9 week session. The academy is scheduled to begin Monday September 18th, 2023 and will meet Monday evenings from 7pm to 9pm.

Class size is limited to 20 students. Applications can be picked up in our

records division from 8am to 5pm Monday through Friday. The deadline for applications is Monday September 11th, 2023 at 5pm.

The academy will offer citizens an opportunity to see how their police department works and what new technologies it has to offer.

Class curriculum includes topics such as patrol functions, hand held radar training, criminal investigations, accident investigations, DUI Investigations, self-defense, firearms, railway enforcement, and use of force issues, as well as, many other police related subjects.





There will also be an opportunity to tour the police facility and discuss current issues such as use of force, pursuit policies and evidence collection.



Ordinance of the Week:

Sec. 8-37 Child Passenger Restraint.

a. A person who operates a motor vehicle in which there is a child less than four (4) years of age shall have said child restrained by a child passenger restraint system. However, if it is reasonably determined that the child will not fit in the restraint system, then said child shall be properly fastened and restrained by a safety belt.

b. A person who operates a passenger motor vehicle that is equipped with a safety belt meeting the standards stated in the Federal Motor Vehicle Safety Standards Number 208 (49 *CFR* 571.208) shall have every child at least four (4) years of age but less than twelve (12) years of age properly fastened and restrained by a child passenger restraint system or a safety belt.

c. A vehicle may be stopped by the Schererville Police Department to determine compliance with this Section. However, the vehicle, its contents, the operator or a passenger in the vehicle may not be searched or detained solely because of a violation of this Section.

d. Any person who shall violate any of the provisions of this Section shall be subject to a minimum penalty in the amount of ninety-five dollars (\$95.00).

e. All penalties collected by the Schererville Town Court for violation of this section, as referenced above, shall be deposited into the General Fund Court Fines - Child Passenger Restraint.
