* **PROPERTY DAMAGE** – Swan Ln- I responded to Swan Ln. for a report of a vehicle with damage to the glass and tires. Upon arrival I observed the vehicle parked in the driveway with the rear windshield broken and shattered, four flat tires, and a large dent in the front windshield. I spoke with the owner who stated that nothing had been taken but all the damage had been done sometime after 11PM the night prior, and called as soon as they noticed the damage. I photographed the damage and added the photos to this report.

* **THEFT** – Austin Ave. On 9/20/2023 at 4:14 P.M. I was dispatched to 1905 AUSTIN AV; ON STATION in reference to a theft that occurred. I arrived and spoke to the complainant whom stated that she ordered a mattress from purple.com that was shipped to her apartment on 9/19/2023 at 11:00 A.M. The complainant stated when she came home at 3:40 P.M. the mattress was no longer on the door step of the apartment building. The complainant stated she checked with neighbors who stated they had not seen the mattress. The complainant advised me that the mattress was worth approximately \$1,300 and that she needed a Police report filed to obtain a replacement. The complainant was able to show me a picture that the shipping company had provided her proving the mattress was delivered. The complainant stated she did not have any suspects whom would have stole the mattress.



* **AUTO THEFT** – Matterhorn Ct . - ON 9/21/2023 Ofc T Mele with the R/P at his apartment. He stated he parked his 2015 Chevy Cruise in the parking lot at approximately 5:00pm on 9/20/2023 and since that time, unknown person(s) had taken it. Ofc T Mele checked the area and found no broken glass nor any other evidence. LPR was checked that vehicle had not had any hits since April of 2023. The vehicle was entered into NCIC/IDACS as stolen. At the time of this report, there are no suspects and only the R/P has the keys.

* **CRIMINAL MISCHIEF** – Redar Park - Officer Ruzga observed broken glass inside the park pavilion. It appears that an unknown individual broke the glass on the Blue Bunny ice cream machine.

* **THEFT FROM VEHICLE** – Novo Dr., - I met with the R/P regarding a theft from his vehicle that occurred during the time frame of 9/21/23 7:30 PM to 9/22/23 2:15 PM. The R/P advised that he normally secures his vehicle, but it was possible that it was unsecured overnight. There were no signs of forced entry on the vehicle. The vehicle was parked in the street directly in front of his residence.

Ordinance of the Week:

Sec. 6-49 Open Burning Prohibited, Nuisance.

- a. No person or persons shall open burn any material except as provided at 326 IAC 4-1-1, *et seq.*
- b. Any person who shall violate any provision of this section shall be deemed a person maintaining a public nuisance.
- c. The Metropolitan Police Department shall and is hereby empowered to enforce the provisions of this section, as amended from time to time.
