ITEM A. PD – New hire Process Update

Chief Sormaz updated the Board on the New Hire Process stating all results were done and calculated by Stanard and Associates. ITEM B. PD – Time Promotions

Chief Sormaz requested approval from the Board for the Time Promotions from 3^{rd} Class Patrolman to 2^{nd} Class Patrolman for Officers Dennis Jashenski, #222, and Martin Spizewski, #223, effective June 12, 2023. Chief Somaz further advised the Board all the letters from their respective supervisors as well as the Commander recommending their advancements were in the packet, and he too, recommends the Board advance these officers. ITEM C. PD – Policy – Police Vehicle Operation and Pursuits/Roadblocks/Notifications #9.06

Chief Sormaz advised the Board several months ago the Department received a mandatory policy from the Law Enforcement Training Board and the Indiana Law Enforcement Academy in reference to Police Vehicle Operation and Pursuits/Roadblocks/Notifications. He stated he has been working with the Board of Safety Attorney, Alfredo Estrada, to blend the CALEA (Commission on Accreditation for Law Enforcement Agencies) Policy and the State Policy. Chief Sormaz requested the Board approve the policy as presented contingent on a final review by Attorney Estrada. Motion made by Mr. O'Rourke, seconded

by Mr. Kouros. Mr. Graf asked Chief Sormaz why not wait for approval until the final review was made by the attorney. Discussion continued for a short time as to what parts of the policy were being updated. Mr. Graf asked if the update was time sensitive to which Attorney Estrada responded that it was. He advised the Board that the State Law had already been passed. He went on to add that other communities have simply adopted the State Law. Schererville, wanting to keep their CALEA certification, have been working to blend the two policies. Attorney Estrada stated further that they are mandated by State Law to have the policy passed as soon as possible. Attorney Estrada clarified for the Board, the changes being made to the policy were non-substantive and were mostly formatting. Chief Sormaz interjected that the final review would occur next week, meaning they would then need to wait three more weeks for the Boards final approval. Motion carries (4-0).

Chief Sormaz advised the Board he received a resignation letter from Officer Arvanitis. His last day was May 21, 2023, with his final paycheck being June 2, 2023. He wished him well on his next endeavor.

Chief Sormaz informed the Board that the festival begins next Wednesday, June 7th and runs through Sunday, June 11th. He requested if the members had time, to come out and visit the officers working the event.

Mr. O'Rourke asked Chief Sormaz if he had the results from the Cop-On-A-Rooftop event. Chief Sormaz stated the Town of Schererville, once again, came in first for the entire state collecting \$6,593.00. Second place was the Town of Dyer, collecting just over \$6,100.00. Chief Sormaz wished Dyer good-luck at next year's event. Chief Sormaz thanked everyone for their support by coming out to the event that day. Chief Sormaz went on to add that there was a bit of a challenge that day as Dunkin Donuts had no lobby access as they were remodeling. Chairman Eenigenburg asked Chief Sormaz if he believed the donations would have been higher if the lobby would have been open, to which the Chief replied yes.
