Mr. Troxell stated that Indiana Code 36-7-14-13 requires annual reporting of Redevelopment Commissions that have Tax Increment Financing (TIF) districts. You have the report before you. This report was due by April 15th 2023 and was submitted on time to the Department of Local Government Finance (DLGF). It is a report showing the revenues collected and expenses paid for the calendar year of 2022 for the TIF districts. It also reflects all debt serviced by the district. As of December 31, 2022 the amount of funds on hand was \$24,553,027.95. Mr. Troxell stated that the Report was prepared by LWG CPA's & Advisors

Mr. Troxell stated that there are separate 4 Resolutions before you this evening. Once acted upon this evening, a written notice of the determination of this Resolution will be made to the Lake County Auditor, the Schererville Town Council and to each of the taxing unit that located within the TIF Allocation area by June 15th 2023. The Department of Local Government Finance (DLGF) will receive it in an electronic format.
