THEREUPON, Presentation

Senator Dan Dernulc and Representative Harold Slager -Legislative Summary

Senator Dan Dernulc and Representative Harold Slager gave a summary report regarding the 2024 Legislation. Rep. Slager spoke about the anti-Semitism bill, which was vetoed. Other bills they spoke about were regarding Ambulance Service, which is house enrolled act 1285. He spoke about Employment of Minors, which had to do with working on farms. Rep. Slager also talked about Education, stating there is a real problem with absenteeism, particularly in Lake County in some of the North County Districts. Rep. Slager stated that they approved a food and beverage tax for the City of Hammond. He stated that another topic had to do with property taxes. He stated that last year he received a lot of calls from people seeing a spike in their property taxes. He stated that they tried to pass a bill that put a smoothing effect, which might go into effect this year, if not then next year for sure. Rep. Slager stated the first bill out the door was regarding Wetlands, it was a negotiated deal between Indiana Department of Environmental Management and the builders. There was a bill passed that does not allow municipalities to file suit against Firearms $% \left(1\right) =\left(1\right) \left(1\right) +\left(1\right) \left(1\right) \left(1\right) +\left(1\right) \left(1\right)$ Manufactures. He stated one last thing he will talk about is House Enrolled Act 1412, regarding puppy mills, requiring pet stores to disclose information regarding the dog's health origin, and microchip status.

Senator Dernulc stated Rep. Slager spoke about several bills, but he has a few he would like to mention. He spoke a little bit more in detail regarding Education, particularly about holding young kids back if they cannot read in third grade and some things they take into consideration. Mr. Dernulc stated they did pass a bill which will replace unsafe lead pipes throughout Indiana, which might include Schererville. He stated that Indiana has an estimated 265,000 unsafe aging lead water lines and this will help set up a procedure to Indiana Hoosiers. Senator Dernulc stated that they did pass the 13th check, along with a long term plan for annual cost of living adjustments for State retired employees. He stated that he's been pushing to make sure our Public Safety employees, when they retire to have a good retirement, he thinks we're lacking in that. Senator Dernulc stated that today he was told that Schererville was awarded \$59,000.00 for Community Block Grant.

THEREUPON, Public Comments Regarding Agenda Items

Dan and Kathy DeYoung, 2112 US 41, Schererville, IN. Mr. DeYoung stated that they will keep their comments brief since they were here last month and talked about the Special Request for the Dark Metal Tattoo business. He stated that he just wants to reiterate that they are against this. Mr. DeYoung stated that they believe the petitioner has not provided a good and sufficient cause to request the Variance. Kathy DeYoung stated that she has a little bit of information since they spoke last month. She stated that she met with businesses all up and down US 41 in the surrounding area and she has a petition signed by several businesses. She handed out a copy of the petition to the Council Members.

Mr. Kevin Dean, 1905 Sir Richard Road, Schererville, IN stated he is here regarding the Tattoo parlor. He stated that he was here last month and the BZA gave a no recommendation and sent it to the Council. He stated that the Town Council recommended that the BZA give a recommendation, but here it is with no recommendation. He stated he doesn't know why the Council is discussing this without getting a recommendation.

Mr. Dean stated that another item he has a problem with is to consider a \$1,000.00 donation, which is Item I on the agenda. He stated last month the Council gave \$2,000.00 of public funds away and now you're giving another \$1,000.00 away. He stated that he doesn't like his tax dollars being wasted, he doesn't believe that the Town of Schererville should be in the business of giving money out.

Mr. Dean stated his last item is to consider the appointment to the Police Commission/Board of Safety, which his Item K on the agenda. He stated he has been coming to these meetings for a couple months now and nothing has been happening. He stated it is his understanding that the board members are paid \$2,000 a year. They meet once a month for ten minutes to one hour, which is a very good income. He asked why the Town Council doesn't try to change your bylaws or whatever it is and make it that you only have three people on the board and you take the \$6,000.00 a year that you'll save and assign a member of the Police and Fire Department to take those two positions.

- Mr. Gorman stated that this is the new Zoning Ordinance, there were not a lot of changes from the one in 2012, but some of the changes include, increased sizes of garages and spaces in residential zones, wider driveway approaches, and increased square footage of solar panels. Mr. Gorman stated that short term rentals will be regulated in this new ordinance and street parking has changed, and the landscaping section has changed.
- Mr. Schmitt stated that Mr. Tom Anderson, President of the Plan Commission is here this evening and stated he would like to thank Mr. Anderson and all the staff members for working many hours on getting this new Ordinance together.

He stated that they have been cutting through $77^{\rm th}$ Avenue from US 41, taking it all the way east to the roundabout. Mr. Gorman stated that local deliveries will be allowed but no other truck traffic.

He stated that every vote this evening has been 5-0 with one exception, the one for the last four months. Mr. Ferraro stated that this Democratic majority has decided to play politics over Public Safety. He stated with that appointment they have run rough shot over the law, they have run rough shot over procedure, they have run rough shot over what is user and customer in this community without anything to offer why it is so important that this person, who was not a Republican and according to the law he's afraid to say he is still not a republican. An early vote is not a certified vote. He stated that he will be filing a FOIA request for his State voting record which will come back empty. Early votes are not certified votes, they cannot be counted until Election Day or they would be unconstitutional. Mr. Ferraro stated that before you get your cupcakes together or

whatever it is you got planned. He stated he just doesn't understand for the life me how this Council and this majority who can get together on every other item here and go 5-0, what is it about this minority appointment that is so important. He stated you are willing to create this level of discord and display to this, that you value Public Safety so little.
