This repeals the old solicitor Ordinance that actually allowed for profit and not for profit. Mr. Gorman stated that this one is just for the not for profit.

Mr. Johnson stated he wanted to make sure what he heard. He heard Mr. Gorman say that from this point forward, if this Ordinance is adopted, for profit businesses are no longer able to go door to door soliciting for business. Mr. Gorman stated that is correct.

ITEM F. Consider Approval to Purchase Property Located at 549 Kennedy Avenue, Schererville, IN from Ray Buzinski in The Amount of \$470,000.00 and to Authorize the Town Manager, Director of Operations, Clerk-Treasurer and Town Attorney to Finalize Execution of Documents (Kennedy Avenue Improvement Project) Mr. Hansen pointed out on the project screen where this parcel is. He stated that it's just north of the North Southern Railroad Tracks. He stated that this property is for the bridge. Mr. Hansen stated that this property was actually in condemnation process, but they met with the property owners and came to this purchase price based on some appraisals that the owner received and some appraisals that the Town received.

Mr. Connelly made a motion to approve the Purchase of Property located at 429 Kennedy Avenue, seconded by Mr. Johnson. Roll call vote: Mr. Johnson - Yes; Mr. Connelly - Yes; Mrs. Arvanitis - Yes; Mr. Guetzloff - Yes; Mr. Schmitt - Yes. Motion carries (5-0).

ITEM G. Award Bid for Wastewater Treatment Plant Bio-Solids Building Project

Mr. Gorman read the letter from Thomas Kuhn at CSK Architects, P.C. Mr. Kuhn stated "Attached please find the Bid Tally Sheet for the above referenced project. We have reviewed the Bid Documents received on April 30, 2024 and recommend awarding the contract and issuing a Notice to Proceed for the Base Bid #1 and Base Bid #2 to the apparent lowest responsive and responsible bidders as follows":

Base Bid #1 - Demolition of the Existing Bio-Solids Storage Building - Grimmer Construction, Inc. in the amount of \$289,000.00

Base Bid #2 - Construction of the new Bio-Solids Storage Building - Hasse Construction Company, Inc. in the amount of \$4,730,000.00.

Mr. Kuhn stated that the total cost of the project is \$5,019,000.00. He stated that they distributed plans to over twenty contractors including ten general contractors but only received two bids.

Mr. Johnson stated that he just wants to make sure that the public is aware how we're funding this project. He stated it is his understanding that we have three million of ARPA funds that have been allocated towards this project and the Town of St. John, IN has to pay 30% based on contract agreements, because St. John dumps 30% of the flow into our treatment plant, which would be \$1.5 million. He stated then the Town will cover the rest of the project.

Mr. Gorman stated that actually we have \$3.2 million in ARPA Funds, and we do have a couple million in ARPA funds that has not been allocated yet, we may be able to contribute that as well.

Mr. Johnson asked, so we're not bonding this, we are going to pay for this in cash, correct? Mr. Gorman stated that is correct.

Mr. Gorman gave the Council a little history on this. He stated that this building started out as a sludge drying building and it's where liquid sludge went on there and it dried naturally through greenhouse effect. It was in a building that had translucent panels on the sides and on the roof. He stated that the building was built in 1983 and it has become unsafe. He stated that the new building is not actually a sludge drying building anymore, it's a storage building because we have another facility that dewaters the sludge. Once the sludge is dewatered it gets stored in this building until we can haul it off and apply it to farmland.

Mr. Connelly made a motion to award the bid for the Wastewater Treatment Plant bio-solids building project as recommend by CSK architects, seconded by Mrs. Arvanitis. Roll call vote: Mr. Johnson - Yes; Mr. Connelly - Yes; Mrs. Arvanitis - Yes; Mr. Guetzloff - Yes; Mr. Schmitt - Yes. All in favor (5-0). ITEM H. Consider Acceptance of Right-of-way and Easement Agreement between the Town of Schererville, Lake County, IN and Enbridge Energy, Limited Partnership

Mr. Gorman pointed out on the projector screen the 100 foot easement. He pointed out the Pennsy Trail that comes from Main Street at the Munster Schererville border. Mr. Gorman stated that two pipes cross that easement, those pipes have been in the ground for many years and we just possess this property.

Mr. Connelly made a motion to accept the right-of-way and easement agreement between the Town of Schererville and Enbridge Energy, seconded by Mrs. Arvanitis. Roll call vote: Mr. Johnson -Yes; Mr. Connelly - Yes; Mrs. Arvanitis - Yes; Mr. Guetzloff - Yes; Mr. Schmitt - Yes. All in favor (5-0).

 $$\ensuremath{\operatorname{Mr.}}$ Gorman stated that $\ensuremath{\operatorname{Mr.}}$ Mora is here this evening if you have any questions.

Mr. Johnson stated he has a couple of questions for Mr. Mora. He stated that he was at the BZA Hearing on this and has a couple follow-up questions. He asked Mr. Mora the following questions:

How big is your lot? - Mr. Mora stated a quarter acre. Do you have it zoned R2? - Mr. Mora stated yes. Do you have neighbors on each side of you on Joliet Street? - Mr. Mora stated yes. You don't have neighbors behind you, what is behind you? Mr. Mora stated the Golf Course. Do you have eight chickens there now? - Mr. Mora stated yes.

Mr. Johnson stated that he used to have chickens in town for many years and he knows from his experience and wants to make sure it's clear for everybody, female chickens don't have to have a male chicken in order to lay eggs. He stated that male chickens are the noisy ones and the female chickens are the quiet ones. Mr. Johnson stated that he saw some pictures of Mr. Mora's coop and it looks like he has a house for the chickens and a runway for them to go out into the yard area that's all enclosed.

Mr. Johnson asked Mr. Mora how long he has had the chickens. Mr. Mora stated since August. He stated he has not had any complaints from his neighbors. Mr. Johnson stated he saw a letter stating that Mr. Mora got these chickens for his family and for his health. Mr. Mora stated that is correct. Mr. Johnson asked Mr. Mora if he or anyone else have gotten sick from the chickens. Mr. Mora stated no.

Mr. Johnson made a motion to approve the Variance of Use to allow eight chickens to be raised on site in the residential zoning district R2 and Joliet St overlay district, Board of Zoning Appeals Case 24-3-2, petitioner Justin Mora, 636 East Joliet Street, BZA unfavorable recommendation with a 3-1 vote, seconded by Mr. Connelly. Roll call vote: Mr. Johnson - Yes; Mr. Connelly - Yes; Mrs. Arvanitis - No; Mr. Guetzloff - No; Mr. Schmitt - No. Motion denied (3-2).

Mrs. Arvanitis made a motion to deny the Variance of Use, BZA Case #24-3-2, seconded by Mr. Guetzloff. Roll call vote: Mr. Johnson - No; Mr. Connelly - No; Mrs. Arvanitis - Yes; Mr. Guetzloff - Yes; Mr. Schmitt - Yes. Motion carries (3-2). ITEM J. Consider Variance of Use to Allow a Drive-Thru within The U.S. 41 Commercial Corridor Overlay District

Mr. Drenth stated he is here seeking a variance for a drivethru, the property is located on the east side of US 41, about one block south of 77th Ave. He stated that they currently have the first building, the north building is constructed and near completion. Mr. Drenth stated that they were granted a drive-thru variance for the building on the North end and he's here tonight seeking a variance for the South building.

Mr. Johnson stated that he loves the building, loves the project, but his concern is regarding traffic. He stated it was something that was addressed originally when Mr. Drenth came in the first time and he wanted the two buildings and the drive-thru. He stated that there was talk about that road on the east side of the building being one way street going north. Mr. Johnson stated that the drawing they have shows it's going both north and south and he is concerned because on the north side of the building where the drive-thru is, that is where the order board is. Mr. Johnson stated that he believes there is only one car stacking available ability before the order board and if there would be a second car, now you're blocking traffic there. He stated that if you made the road all northbound traffic and you put the whole left side there by the curb as additional stacking for your drive-thru, he would be 100% in favor of this. Mr. Johnson had further suggestions on what he would like to see and Mr. Drenth stated he doesn't have a problem with that. Mr. Johnson asked Mr. Drenth if he can make this work. Mr. Drenth stated yes he can.

Mr. Johnson made a motion to approve the Variance of Use to allow a drive-thru within the US 41 Commercial corridor overlay district, Board of Zoning Case #24-4-3, petitioner Kenneth Drenth, 7725 U.S. 41 (Boulevard Commons, Lot 1), BZA Favorable recommendation 4-0 from the April 22, 2024 meeting and adopt their findings of fact and conclusions into his motion and with a couple additional conditions he has. Mr. Drenth would move the order board a little bit more towards the center of the building to give more room there and to make the roadway on the east side of the building all northbound with the left side of that road adding additional stacking for that drive-thru, seconded by Mr. Guetzloff. Mr. Gorman stated that this is an annual request we get from the Lake Central Education Foundation and the amount is the same as last year.

Mr. Guetzloff made a motion to donate \$1,000.00 to the Lake Central Education Foundation, seconded by Mr. Connelly. Roll call vote: Mr. Johnson - Abstain; Mr. Connelly - Yes; Mrs. Arvanitis -Yes; Mr. Guetzloff - Yes; Mr. Schmitt - Yes. Motion carries (4-0-1). Mr. Johnson stated that he abstained because he is on the board of the Lake Central Education Foundation.

Mrs. Klein stated that all of the donations we received in April 2024 were all in-kind donations. Mrs. Klein read the list of donations into the record.

Mr. Guetzloff made a motion to accept the donations as read, seconded by Mr. Connelly. Roll call vote: Mr. Johnson - Yes; Mr. Connelly - Yes; Mrs. Arvanitis - Yes; Mr. Guetzloff - Yes; Mr. Schmitt - Yes. All in favor (5-0).

THEREUPON, Business from the floor

Mr. Ted Bogucki, 1112 Willowbrook Drive, Schererville, IN stated that he has lived in his home for approximately 10 years and in the subdivision he's noticed there is a detention pond in the center of the subdivision. He stated it has a high concentration of iron okra, so besides having a high water table, several residents are dealing with problems with their sump pumps in the home. He stated that he feels that the pond needs to be dredged, along with the Schererville ditch. After Mr. Bogucki explained to the Council what is happening in their homes from this detention pond, Mr. Schmitt asked Mr. Gorman, Mr. Hansen and Mr. Nondorf to set up a meeting with this gentleman.

Mr. Alex Ferreira, 233 Fairview Lane, Schererville, IN stated that he has been a Schererville resident for 22 years and he would like if the Town of Schererville would consider including a Crime and Drug Free lease addendum, such as the one he is presenting. He provided the Council Members with a copy of a Crime & Drug Free Lease Addendum. Mr. Ferreira stated that this would be for all residential lease agreements in the Town of Schererville to help deter criminal activity and to remove non-compliant tenants.

Mr. Schmitt advised Mr. Ferreira that he should set up an appointment to meet with the Town Staff and possibly someone from the Police Department to discuss this.

Mr. Jeff Minard, 1279 Poppyfield, Schererville, IN stated he appreciates the opportunity to talk, but he's very disappointed to continue to see this partisanship going on. It seems suspicious to him how we always vote no for any exceptions for chickens, but yet the same person that brought out that Councilman Johnson had chickens is the same person you've been trying to put on the Public Safety Board since January and he hasn't qualified.

Anton Gant, 1119 Stone Bridge Drive, Schererville, IN stated that he is one of those new tenants in the subdivision that was discussed earlier regarding the detention pond in his subdivision. He stated that he has been here for approximately two years and his basement has flooded three times. He said that he is from Chicago and he never had to deal with a sump pump until he moved here. Mr. Nondorf, Public Works Direct stated that he will schedule a meeting and meet with him. Kevin Dean, 1905 Sir Richard Road stated that he wanted to thank the Council this month for not giving away any of the tax dollars to certain entities that they feel were in need of his tax money. Mr. Dean stated that he listened to the person who wants to raise chickens on his property and you're saying no to that. He stated that the resident's neighbors are not complaining about them and asked why the City Council is taking action against this person.
