Mr. Troxell stated that London Witte Group has been handling our water and wastewater compilations monthly for many years. He stated that there is an adjustment in their monthly charge. They were charging \$900.00 per month and they're asking for an increase to \$1,500.00

Mr. Connelly made a motion to accept the Letter of Engagement from London Witte Group, seconded by Mrs. Arvanitis. All in favor (3-0).

ITEM C. Consider SCADA Services Proposal from Austgen Electric, Inc. in the amount of \$995,175.00 for the Water Department (Will be Expending some ARPA Funds)

Mr. Gorman stated that they made up SCADA, an acronym that stands for "Supervisory Control and Data Acquisition. Mr. Gorman stated that the current system that automates the water system was first put in in 1992. The proposal that is being presented involves replacing all the data processing units at each water tower pumping station, as well as the Public Works facility. It will update the outdated computer system at each of these locations and provide a more consistent data stream of information to allow personnel to gather information in real time. Mr. Gorman stated that this process involves custom programming for each location.

Mr. Connelly made a motion to approve the SCADA Services Proposal, seconded by Mrs. Arvanitis. All in favor (3-0).
