## NEIGHBORHOOD REPORTS

- November 9, 2024 Appletree Dr Suspicious Incident- Officer responded to a report of the neighbor's at the given address sitting in their vehicle for over an hour in their driveway. I spoke with the occupants who advised they were just talking. Nothing further.
- Novwmber 22, 2024 Fountain Park Drive- Suspicious Person- While on patrol, officers observed a middle-aged male pushing an Aldi shopping cart near the listed location.
