THEREUPON, Old Business

ITEM A. Consider Acceptance of Conveyance of Property (Town Hall, Police Station, and Court) from the Building Corporation to the Town of Schererville, Lake County, Indiana and to Authorize the Town Manager, Director of Operations, Clerk-Treasurer and Town Attorney to Finalize Execution of Documents (Deferred at July 10, 2024 Meeting)

Attorney Austgen stated that the Schererville Building Corporation Board of Directors met today, August  $14^{\rm th}$ . He stated that the meeting was held for the purpose of catching up the entity formalities of the entity itself and addressing the transfer of the property owned by the Building Corporation back in ownership of the Town of Schererville. Attorney Austgen stated that back in 2002 when the Town Hall and Police Station were built, the financing method chosen was the Building Corporation lease purchase financing. He stated that was sufficient to make all the amenities correct and the details for the project were brought together. Attorney Austgen stated that those bonds have now been paid off and you're looking at other possible uses of the Building Corporation entity as the downtown of Schererville continues its development. Attorney Austgen stated that it was unnecessary for the Building Corporation to continue to own the property, it is the tax payer's He stated that the Board of Directors met and they property. unanimously approved to revert the ownership to the Town of Schererville through the Town Council. Attorney Austgen stated that it should be noted that Tom Kouros, Kathy Stone and Robin Thiel served the entire 22 years on that board.

Mr. Connelly made a motion to accept the property, Town Hall, Police Station and Town Court, from the Building Corporation to the Town of Schererville, seconded by Mr. Johnson. All in favor (3-0).

ITEM A. Consider Acceptance of Professional Services with Peterson Consulting Services, Inc. in the amount of \$4,050.00 for the Capital Asset Report for Fiscal Year Ending December 31, 2024

Mr. Gorman stated that Peterson Consulting prepares the Gateway summary schedule for the Town of Schererville's annual finance reporting to the State Board of Accounts. He stated that some of these include the Town's asset additions as well as completed projects and land acquisition.

Mr. Johnson made a motion to accept the Professional Services with Peterson Consulting Services, seconded by Mr. Connelly. All in favor (3-0).

Mr. Gorman stated that Mr. Gralewski is looking to go into the office space at the Old Animal Hospital on Route 30, just east of RAL Landscaping, which is now home to Cliff's Heating and cooling. Mr. Gorman stated that it came with a favorable recommendation from the BZA 4-0.

Mr. Johnson asked Mr. Gralewski if there will be exterior signage and if so, how large will that be. Mr. Gralewski stated that it will be underneath Cliff's Heating and Cooling sign. He stated that's the only exterior signage, and once he makes a logo that will probably be on the window. Mr. Johnson asked Mr. Gralewski what his hours will be. Mr. Gralewski stated they will be 12:00 pm to 8:00 p.m., so his last appointment is at 5:00 p.m. Mr. Johnson asked Mr. Gralewski how long he has been in business. Mr. Gralewski stated he just celebrated 16 years tattooing professionally.

ITEM E. Consider Donation to NICK Foundation for "The Great Gold Rush Race 6.0" in the requested amount of \$2,000.00

Mr. Gorman stated that this is a donation request from the Northwest Indiana Cancer Kids Foundation. They requested \$2,000.00, the same figure as last year. He stated that it went before the donation committee and they approved it.

Mr. Connelly made a motion to donate \$2,000.00 to NICK Foundation, seconded by Mr. Schmitt.

ITEM F. Award Bid for Iris Lane Water Main Replacement Project

Mr. Simstad stated that they opened bids on August  $9^{\text{th}}$ , they had six bidders. He stated that the Engineers opinion of cost was \$373,200.00 and the lowest and most responsive and responsible bidder was Rex Construction Company Inc., in the amount of \$296,750.00. Mr. Simstad stated that their recommendation is to award the bid to Rex Construction Company Inc.

Mr. Johnson made a motion to award the bid for the Iris Lane Water Main Replacement Project to Rex Construction Company Inc., seconded by Mr. Connelly. All in favor (3-0).

Mr. Gorman stated that during reports, Mr. Reardon was skipped and asked if he could give his report now. Mr. Gorman stated that Mr. Reardon has been working on our Illiana Project and is going to give us an update.

Mr. Reardon read the following update.

- Engage professionals for the delivery of technical Studies include but not limited to an ALTA Survey, Environmental Audit, Geotechnical Drilling, Wetland Delineation, Topography, and Utilities. Assessments-Reports to be completed by qualified entity giving preference to RCS or firm with knowledge of site and in good standing with town. Geotech, Environmental, and Wet Delineation site visits completed. Geotech report completed and submitted. Wetland map created and submitted. Data entry and report in progress. Report expected week of September 9th. Environmental User Questionnaires circulated. Report due first week in September. Facilitate bids from demolition and paving companies.
- Establish a project management office (PMO) providing a specific strategic roadmap and milestones throughout Phase 2 (Design Phase).

- Provide Town Staff and Officials with Summary Reports throughout Phase 2 (Design Phase) in the form of a bi-weekly meeting.
   Communicate by email, telephone, and text. Establish monthly
  - Communicate by email, telephone, and text. Establish monthly Zoom meeting.
- Completed Interviews and pending selection of qualified Design Firm to lead Phase 2 (Design Phase) of the Project. Review interview notes and Zoom meeting. Conversations with Town Administration on going. Request Executive Session with Town Council to discuss leading to a selection of Design Firm.

Mr. Johnson reminded Mr. Reardon that there is a Study Session on Wednesday, August  $28^{\rm th}$ .

Mr. Gorman read the list of donations for the month of July 2024 into the record.

Mr. Connelly made a motion to accept the donations as read, seconded by Mr. Johnson. All in favor (3-0).

Mr. Kevin Dean, 1905 Sir Richard, Schererville, IN, stated that it is really hard to say no to kids with cancer, but his argument is you taking tax dollars and using them for these donations. He stated he would appreciate it if the Town Council would try to refrain from using our tax dollars for things outside of Schererville.

Mr. Dean Johnson, 7412 Foxwood Drive, Schererville stated that oftentimes he is here with complaints, but not today. He stated that he came to thank Mrs. Arvanitis and the Departments that have been working along with her in regards to some issues that he was having. He stated that the Parks Department and Public Works have been out by the fencing behind Burr Street and they've been mowing and weed whacking that, it looks fantastic. He stated that Public Works also came out and cleaned up the entrance way to their subdivision. Mr. Johnson stated that in regards to the donations that the Council gives, he is with them 100%. He stated listening to all the in kind and monetary donations that the Town receives, he would think that the Town will continue to be a good neighbor when it comes to giving to other entities and/or foundations.

Mr. Dennis Hunter, a Veteran of the United States Army and a former Department of Justice employee stated he is here to bring to the Council a club he is involved with. He stated they are worldwide and he's trying to introduce it to Northwest Indiana. It's called "Experience the Smart Money Club" and the newest thing they have is a wealth mentorship program, it's for the youth but is open to everybody. He stated that expert instructors teach you online about Bitcoin Stocks, cryptocurrency and the new stuff that's coming up, for example AI. Mr. Hunter went into detail what the Club does and thanked the Council for letting him give his presentation.

Georgianna Glavas from Logan's Love, stated she is here to thank the Town Council, the Parks Department and the Police and Fire Departments for allowing all of the events that they have Logan Love's has done. She stated she would like to invite everyone to the Autism walk this weekend on Sunday at Rohrman Park.
