Mr. Hansen stated that before you tonight is a real estate commitment between the Town of Schererville and the purchaser, which includes a payment total of \$245,000.00, which was the appraised value. He stated that the time period for this development is estimated approximately two to three years from the day of closing. Mr. Hansen stated that the commercial development will be two to four outlets on the ground floor and three to five units on the second or higher. He stated that the purchasers are owners of Little Italy in Dyer, IN and they're looking to expand their business.
