ITEM A. Approve Sale of Real Estate Located at 22 W. Joliet Street by the Town of Schererville with Conditions

Mr. Hansen stated that this is the property located just west of the Town Hall. He stated that the Town of Schererville has been purchasing property over the last twenty years to start a downtown Redevelopment. Mr. Hansen stated that before you tonight is a real estate commitment between the Town of Schererville and the purchaser, which includes a payment total of \$245,000.00, which was the appraised value. He stated that the time period for this development is estimated approximately two to three years from the day of closing. Mr. Hansen stated that the commercial development will be two to four outlets on the ground floor and three to five units on the second or higher. He stated that the purchasers are owners of Little Italy in Dyer, IN and they're looking to expand their business.

Mr. Johnson asked Mr. Hansen if we are going to make this subject to Plan Commission approval. Mr. Hansen stated that is correct.

Mr. Johnson made a motion to approve the sale of real estate located at 22 West Joliet Street by the Town of Schererville with conditions as outline by our acting Town Manager tonight, subject to all land and use approvals, seconded by Mr. Guetzloff. All in favor (5-0).
